Treasurers Report for financial period 1st May 2024 until 30th April 2025

- 1. The FOSM annual accounts to 30th April 2025 have been independently examined and approved by Mr. Frank Port.
- 2. We must submit a form CC16a to the charity commission each year end. I have completed this form ready for submission. I have a few comments to make on this form: -
 - 2.1 Subscriptions were slightly down this year.
 - 2.2 Donations and events are generally closely associated. (The more events we put on, the more donations we normally receive). This year donations have dropped by over
 - 2.3 No legacies received this year.
 - 2.4 We received £491 in sponsorships this year.
 - 2.5 HMRC took longer than normal to process our claim, and we did not receive payment until the 23rd of May (beyond our year-end) We have now received £1,149.59 Gift Aid and this was very slightly down on last year.
 - 2.6 Most of our funds are held in a 100-day notice account with The Charity Bank.
 - 2.7 FOSM has passed £9,365 to St Mildred's PCC for roof repairs during this year.
- 3. We made a loss of £1,487 for the year. (Note This after passing £9,385 to St Mildred's)
- 4. On 30th April 2025, our FOSM bank accounts stood at £10,581 in Nat West, £83,817 in the Charity Bank and £96 in cash.
- 5. As always, my sincere thanks go to: -
 - Brian Guest for the time that he has spent maintaining records and giving me help and advice when asked. Brian also keeps our website up to date and is involved with our annual submission to the Charity Commission.
 - 5.2 <u>The team at Webbs Ironmonger's</u> in Tenterden for running our ticket office for events. They do a brilliant job.
 - 5.3 Mr Frank Port, for carrying out the independent examination of our accounts. (Frank has retired from MMP accountants).
 - 5.4 All the other FOSM committee members, for the work and the time they donate to ensure that we are a successful organisation.
- 6. I will shortly be resigning as a FOSM committee member and trustee. However, I will gladly give advice after my retirement if asked.
